Market stands at crucial levels ahead of the weekly expiry.

Nifty on Wednesday traded sideways and closed on a flat note. Overall index breadth turned out to be negative with 30 stocks closing in red. Insurance stocks saw a minor bounce back with HDFC Life (+2.56%) ending as Nifty's top gainer. On the other hand, Bharti Airtel (-2.25%) closed as the index's top loser for second straight session. Based on the technical parameters, we adopt a cautious view on Nifty near 24500 levels. Heading into the weekly expiry on Thursday, fresh long additions are only recommended post a clear breakout above 24500. On the other hand, the possibility of a running correction cannot be ignored. In case of the same, 24200 shall serve as a firm support on the downside.








Banking stocks continue to outperform.

Bank Nifty witnessed a decisive move on Wednesday as it breached the resistance zone and closed above 53000 levels earning 571 points. Canara Bank (+3.34%) emerged as the index's top gainer for the second consecutive session while heavyweight HDFC Bank hit a new all-time high at 1865, eventually closing with a rise of 1.85%. On the technical front, the breakout above 53000 in Bank Nifty is expected to have triggered a short covering and hence, price can be seen acquiring higher levels up to 54000 in the upcoming days. On the down side, correction up to 52800 can be seen as a buying opportunity. A deeper and significant support is seen at 52500.

- Reserve Bank Governor-headed six-member Monetary Policy Committee (MPC) is scheduled to meet on December 4 to 6, 2024. The decision of the rate-setting panel will be announced on December 6 by Governor Shaktikanta Das.
- December has historically been a bullish month for the Nifty50 index with average monthly gains of ~3% in the last 20 years.
- A total of 45 stocks have been added to the futures and options (F&O) segment by National Stock Exchange (NSE) from 29th of November 2024.
