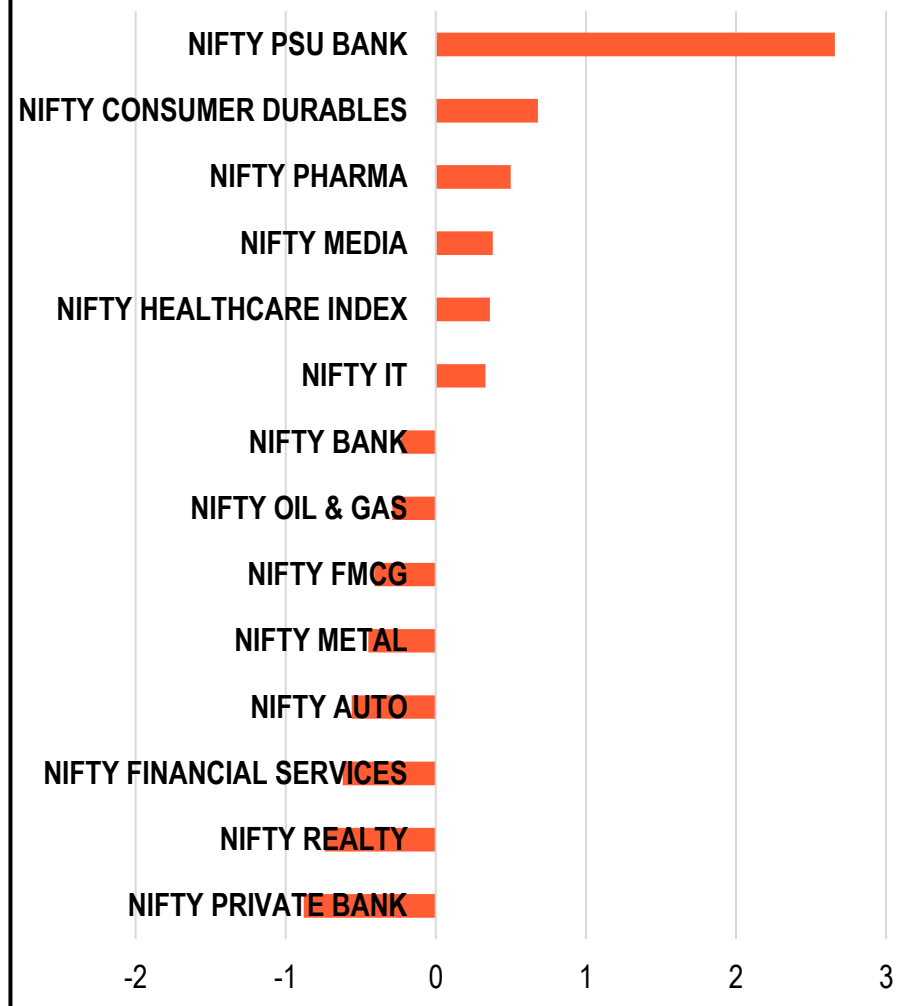

DAILY SECTOR PERFORMANCE (%)





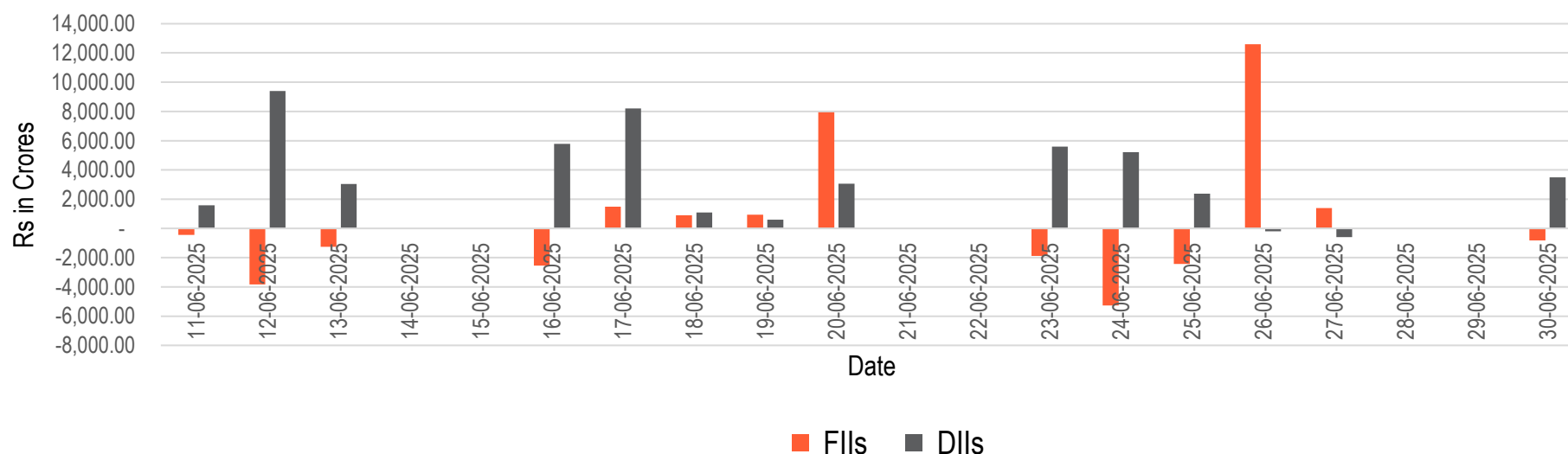

Commentary

- Market witnessed a profit booking on Monday as both Nifty and Bank Nifty faced rejection from respective resistance levels.
- Nifty closed with a decline of 120 points but managed to hold on to 25500 level.
- Nifty Realty index saw another bearish session while PSU banking stocks, especially from the mid-cap and small-cap space, attracted buyers interest.
- In case of a breakdown below the support of 25450, Nifty can see an extended correction of 200-250 points on the downside.
- In case of Bank Nifty, a positive stance can be held till price trades above 57000.
