



Commentary

- Nifty extended its winning streak for the third straight session, surging 120 points on the weekly expiry. Bank Nifty also advanced 200 points, reclaiming the 58000 mark. Both indices respected their key supports at 25450 and 57600, reversing strongly from those levels.
- The IT index (+1.20%) remained the top performer for the second consecutive session, followed by strength in the Auto sector (+1.07%).
- From a technical perspective, Nifty now faces resistance near 25700. A breakout above this zone could trigger short covering and lead to an extended rally of 200-300 points, with 25600 acting as a strong intraday support. Bank Nifty continues to build positive momentum and appears poised to test new all-time highs in the coming sessions.
