

INDEX VIEW: BANK NIFTY






Buyers lose grip during second half of the weekly expiry.

Market traded with high volatility during Thursday's trading session as Nifty experienced swings in both the directions but eventually closed on a negative note losing 13 points. On its daily chart, the index was seen giving up initial gains after it slipped by around 200 points from the day's high to close just around 23000 level. Going into the final session of the week, we maintain a cautious view on Nifty with 22800 as a critical support. Breakdown below the same is expected trigger fresh short additions. At the higher end, resistance is seen at 23200 and 23400 levels.

INDEX VIEW: BANK NIFTY





Index sheds off initial gains to close near day's low.

Bank Nifty experienced a similar price action to Nifty as the index plunged by around 500 points from its day's high to closed near 49300. On the daily chart, it has seen an 'inverted pin bar' pattern formation that indicates lack of confidence among the buyers as of now. For Friday's trading session, we shall maintain a cautious view on the index with 49200 and 48700 as the support levels. The range from 49850-50000 poses as a strong resistance zone.


