





### **Commentary**

- Nifty traded with strong bullish momentum on Wednesday, closing above the 25300 mark with gains of 178 points.
   Bank Nifty too sustained above 56500, recording an intraday rise of 303 points.
- Nifty Realty appears to be forming a base around the 860 level while the PSU Bank index seems to be in a
  gradual uptrend, reflecting steady accumulation in select stocks. Rupee appreciation (88.76 to 87.77) is expected
  to boost import-heavy sectors like OMC, aviation, FMCG but can pressurize export-oriented stocks from the IT,
  pharma & textiles space, while signaling stable macro sentiment and potential foreign inflows.
- For Thursday's session, Bank Nifty faces resistance in the 56900-57000 zone, and fresh long positions can be considered only after a decisive breakout above this level. A positive bias can be maintained in Nifty as long as the index trades above 25200.
