



Commentary

INDEX VIEW

- The recovery that began on Friday, continued during Monday's trading session as well. Rising by 227 and 417 points respectively, both Nifty and Bank Nifty index were seen filling the gap on daily chart.
- However, post the bounce back, prices are seen arriving near their respective resistance levels. Hence, going into Tuesday's trading session, the price action around these levels needs to be closely monitored. The sideways momentum in Nifty is expected to continue and the index should spend some more time within the broader range of 24500-25200.
- A positivity was seen across all the sectoral indices on Tuesday led by the IT index.
