



# **Commentary**

- Sideways momentum sustained in the market during Wednesday's trading session as Nifty hovered within a 150 points range and closed on a flat note. Bank Nifty on the other hand, saw a failed breakout attempt above 57200 level, eventually closing with a rise of 162 points.
- PSU banking stocks were seen attracting buyers interest yet again. PNB with a move of +2.43% was the top gainer from Nifty PSU Bank index. Minor profit booking was seen in the Pharma & Healthcare space.
- Going into Nifty's weekly expiry today, we would hold a cautious view while price trades within the range of 25200-25250. The index can be seen gaining fresh bullish momentum only post a breakout above the same. A positive bias can be maintained in Bank Nifty above 56900 level.
