






Pharma and health care stocks heal the market.

Market witnessed a recovery on Monday as Nifty bounced back post a gap down opening. On its daily chart, the index was seen respecting the support zone around 22800 levels while it closed near the day's high. Going into Tuesday's trading session, a positive bias can be held in Nifty with an expectation of continuation in the bounce up to 23100 and 23250 levels. On the downside, 22700-22800 shall be acting as the support zone.

INDEX VIEW: BANK NIFTY





IndusInd Bank leads the index with more than 2 per cent gain.

Bank Nifty saw a recovery from day's low around 48500 level and closed near the day's high gaining more than 150 points. On its daily chart, the MACD oscillator can be seen trading around signal line support and hence, the index seems to be standing at a 'make or break' level. Going into Tuesday, the bounce back is expected to continue with 49500 and 49800 acting as resistance levels. On the contrary, support shall lay at 49000 and 48500.
