

## Commentary

- Markets reacted negatively to the government's Budget reforms for FY27 as Nifty plunged nearly 500 points on Sunday, breaching the crucial support zone of 24900. Bank Nifty also witnessed heavy selling pressure, slipping close to 1200 points.
- Except for the IT index, where heavyweights such as INFY, WIPRO and TCS provided support to Nifty, all major sectoral indices ended in the red. PSU Banking and Metal indices bore the brunt of the sell-off, declining by 5.57% and 4.05% respectively.
- Heading into Monday's trading session, 24500 is seen as a strong support for Nifty, where prices may attempt to stabilize in case of early weakness, while 25000 is expected to act as a stiff resistance on the upside.
