



INDEX VIEW: NIFTY






Index arriving near 23000 amid profit booking across sectors.

Nifty on Tuesday faced a strong rejection from 23550 levels and plunged by ~400 points to close near the day's low. On the daily chart of the index, price is seen arriving at the 20 DEMA support after witnessing a profit booking since last five trading sessions. Hence, going into Wednesday's trading session, 23000 is expected to act as a crucial support for Nifty where the index should attract buying interest. However, in case of a breakdown below the same, an extended selling of 200-300 points can be seen. At the higher end, an intraday resistance stands around 23300 levels.

INDEX VIEW: BANK NIFTY





Index slips below 51000.

Bank Nifty faced a rejection from 51700 levels and closed near the day's low declining by more than 700 points. The structure on its daily chart is currently indicating a possibility of neckline retest around 50600 levels which was breached on March 24. Hence, 50500-50600 shall be acting as the support range for Wednesday while resistance would be expected around 51000 levels. Fresh long additions in the index would be recommended only once price starts sustaining above 51000.


