





# **INDEX VIEW: NIFTY**






## Index in a consolidation phase as buyers take a breather.

Nifty traded sideways on the weekly expiry and closed flat after testing the support level of 24200. On its daily chart, the index has witnessed a 'doji' candle formation which indicates lack of momentum in the market as of now. Price seems to be in a short term consolidation phase post a bull run from the lower levels of 21750. As we head into the final trading session of this week, a sideways price action is expected in the index with 24000-24500 acting as the broader range. Intraday support level is placed at 24200.

# INDEX VIEW: BANK NIFTY





### Index continues to hold on to 55000.

Bank Nifty witnessed some profit booking during Wednesday's trading session but managed to closed above 55000 in spite of an intraday breakdown. On its daily chart, the index can be seen in a consolidation phase with 10 DEMA acting as an immediate support. Going ahead, 54000-56000 is seen as the broader range for Bank Nifty while from an intraday perspective, a strong resistance stands around 55500 levels. On the downside, 55000 and 54200 are seen as the support levels.


