



INDEX VIEW: NIFTY





Highest FII outflow in over two months leads Nifty below 24800.

Nifty plunged by 261 points during Tuesday's trading session after facing a strong rejection from 25000 level earlier in the day. Breaking below the support level of 24800, the index witnessed a 'bearish marubozu' formation on its daily chart which indicates a comeback of the sellers. Going into today's trading session, the bias on Nifty would be bearish with 24800 acting as a resistance. On the downside, an immediate support can be seen at 24500 while a breakdown below the same shall lead to an extended selling pressure where price might make an attempt to fill the gap formed on 12th of May.

INDEX VIEW: BANK NIFTY





Index breaks below 55000.

Losing nearly 550 points, Bank Nifty slipped below 55000 on Tuesday. On its daily chart, the index can be seen trading within a corrective channel with lack of clarity in terms of the further trend as of now. Heading into Wednesday's trading session, we would hold a bearish bias on Bank Nifty till price trades below 55000. An immediate support is expected at 54500 level while a breakdown below the same shall lead to an extended correction of 300-500 points.


