






IT, pharma and auto stocks stabilise Nifty on a silent weekly expiry.

Nifty traded with a positive bias on Thursday as price experienced recovery post a gap down opening. Overall it was a non-volatile weekly expiry where the index closed with a minor gain of 50 points. Looking at the technical structure, price seems to be attempting a bounce back holding on to the support of 23000. For Friday's trading session, the momentum is expected to continue up to 23500 levels which forms a critical resistance while intraday support shall lay at 23200 and 23000. Fresh negativity is expected only in case of a break down below 23000.

INDEX VIEW: BANK NIFTY





Index stays sideways as bulls try to defend 48000 level.

Bank Nifty traded sideways on Thursday and closed with a decline of 135 points. On its daily chart, the index can currently be seen consolidating within a tight range from 48000 to 49700. Going into today's trading session, 49000 is seen as an immediate resistance while a breakout above the same shall lead to an extended move of 700-1000 points on the upside. On the contrary, support continues to lay at 48000.
