






### **INDEX VIEW: NIFTY**





#### Squeeze in volatility ahead of the monthly expiry.

During Tuesday's trading session, Nifty consolidated within a narrow range of 200 points and closed with a minor decline of 25 points. Since past three sessions, the volatility has been seen contracting as price constantly traded within previous day's range. Going into Nifty's monthly expiry today, there's a high possibility of price breaking the shackles in either direction due to an expansion in the volatility. 23250 can be seen as an immediate support while on the higher side, the range of 24000-24150 is considered to be the resistance zone for the index.

# INDEX VIEW: BANK NIFTY





#### A quiet monthly expiry for Bank Nifty.

A similar price action as of the Nifty index can be seen on the daily chart of Bank Nifty which has stayed silent during the last couple of trading sessions. In spite of its monthly expiry on Tuesday, Bank Nifty just hovered within a range of 300 points and closed with a loss of 84. On its daily chart, price can be seen stabilizing around the 200 DEMA support while the RSI oscillator too has arrived at its respective support zone. Going into the next couple of trading sessions, 52000 stands tall as a crucial hurdle for Bank Nifty while an intraday support for Thursday shall lay around 51000.

#### **Market info**

- NSE will revise the lot sizes for all new index F&O contracts introduced from November 20, 2024, onwards. Lot size for Bank Nifty will change from 15 to 30 on December 24, 2024, end of the day. Lot size for Nifty will change from 25 to 75 on December 26, 2024, end of the day for Nifty.
- The US Federal Reserve delivered a 25 bps rate cut during its December 16-18 monetary policy meeting. Looking ahead, the Fed now anticipates just two 25-bps cuts in the year 2025.
