

Commentary

- Nifty faced rejection near the 26250 level for the second consecutive session and eventually closed on a bearish note. Bank Nifty also witnessed selling pressure from the 59500 zone, ending the session lower by 115 points.
- On the sectoral front, the Nifty Metal index has seen a short-term rejection from its resistance zone around 10800. A cautious approach is advisable in metal stocks until the index manages a decisive breakout on the upside.
- The market may face some selling pressure on Friday, with 25975 acting as a critical support for Nifty. Selective participation is expected, as markets are likely to remain sensitive to FII flows, currency movements and global macro cues.
