






### **INDEX VIEW: NIFTY**





#### Market lacks momentum.

Nifty continued to trade sideways on its monthly expiry too, closing with a minor gain of 22 points. The constant doji candle formations on daily chart indicate a lack of conviction among both buyers and sellers at current levels. Going into Friday's trading session, 23500 and 23250 are expected to act as a support levels while resistance zone is seen within the range of 24000-24150.

## **INDEX VIEW: BANK NIFTY**





#### Bulls yet again fail to make a mark.

Bank Nifty index failed to capitalise on the initial bullish momentum as it faced a rejection from 51750 levels and closed on a negative note. Going ahead, it is expected to trade sideways within the broader range of 50000-52000. A simple 'buy on dip' and 'sell on rise' strategy can be implemented till price gives a decisive breakout.
