



INDEX VIEW: NIFTY






<u>Index holds on to the support levels prior its weekly expiry.</u>

Nifty on Wednesday witnessed a slight recovery as it bounced back by nearly 200 points from the day's low and closed with a gain of 166 points. On its daily chart, the index has seen a 'bullish inside bar' formation which hints towards a come back of buyers. Heading into the weekly expiry today, 23000 shall continue to act as a critical support level on the down side while view on the index can be maintained on the positive side till price trades above 23000 levels. On the other hand, resistance is seen at 23600.

Bank Nifty saw a decent bounce back during Wednesday's trading session. A buying follow-through was seen post a gap up opening as the index closed with a gain of 520 points. This sustained positivity indicates bullish sentiments around lower levels. Going into today's trading session, Bank Nifty is expected to trade within the broader range of 50700-51800. An immediate support is expected at 51000 while a positive bias can be maintained till price trades above the same.
