





## Realty stocks help Nifty to re-build.

Post a gap down opening on Monday, Nifty managed to absorb maximum loses and eventually closed just 34 points lower. On the daily chart, price can be seen closing above the 20 DEMA support that lays at 24638 as of now. For Tuesday's trading session, 24500-25000 is seen as an intraday range. A breakout above 25000 is expected to ignite fresh bullish momentum among the traders while a breakdown below 24500 is expected to bring another 300-500 points correction.

# Index rebounds from lower levels as PSU banks continue to attract buyers.

Bank Nifty index saw a sharp reversal from the support level of 55500 and closed with a gain of 153 points. On its daily chart, price can constantly be seen respecting the 20 DEMA support. For Tuesday's trading session, a buy on dip strategy can be implemented in the index till price trades above 55500. A deeper support lays at 55000 while at the higher end, an immediate resistance is seen at 56000.
