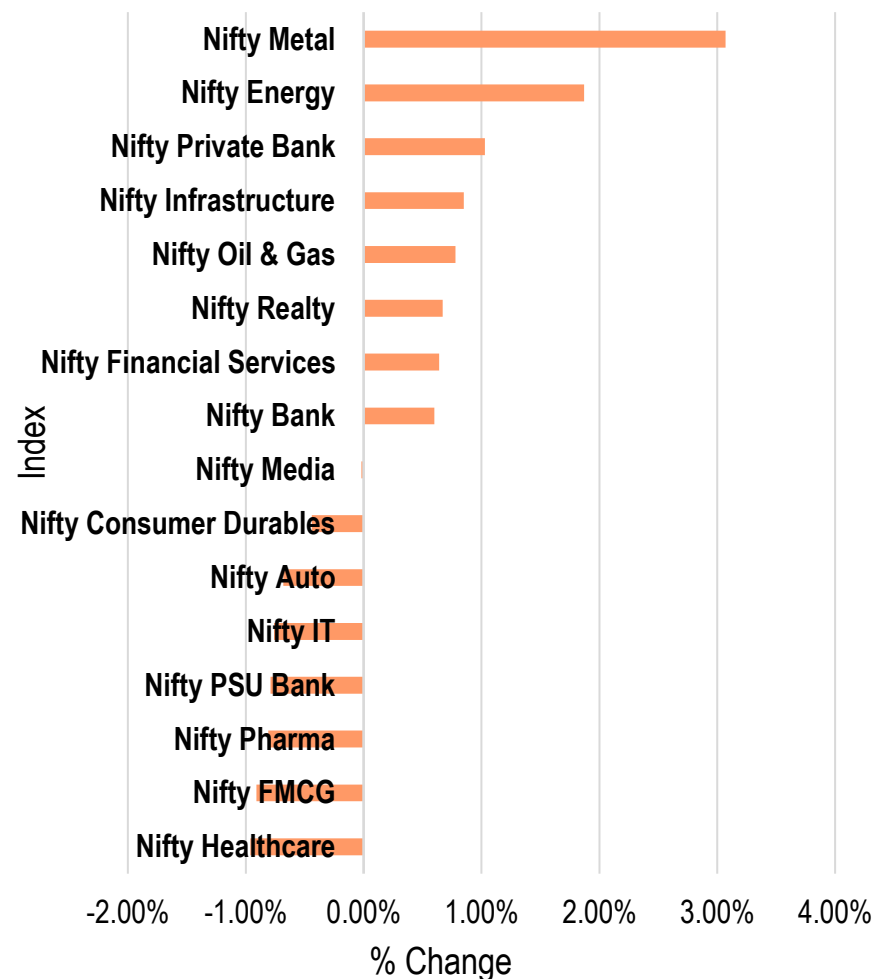

Commentary

- Post initial selling pressure, Nifty witnessed a sharp recovery from the day's low of 25159 and closed near the 25400 level. Bank Nifty outperformed Nifty, surging 359 points to end just shy of the 60000 mark.
- The bull run continued in the Metal space, which gained 3.07%, while the rebound in Energy stocks extended further. Auto and Consumer Durables indices also showed signs of selling exhaustion near their respective support levels, indicating a potential bounce back. After declining more than 8% from its recent swing high of 23492, the Pharma index has reached a crucial make-or-break support zone around 21400.
- Heading into the final trading session ahead of the Union Budget on 1 February 2026, Nifty is expected to trade with a positive bias. Any pullback towards the 25350 zone could be viewed as an intraday buying opportunity.
