



Commentary

- Nifty closed with a gain of 117 points on Wednesday, though it faced resistance near the recent swing high of 26100. Bank Nifty extended its upward move, adding 171 points.
- Broad-based buying was witnessed across sectors, except Auto, which saw profit booking of 0.73%. Technically, Infrastructure and Energy sectors are seen gaining momentum.
- For Thursday's session, a cautious approach is advised around higher levels. Given the recent one-way rally, the possibility of a pullback or time correction cannot be ruled out. A breakdown below 26000 may trigger intraday selling of 70-80 points, while the upside remains capped near 26100.
