### **INDEX VIEW: NIFTY**






#### Bears take a halt.

During Friday's trading session, market failed to hold on to the initial gains as Nifty slipped by more than 100 points from the day's high to close with a rise of mere 63 points. A 'doji' candle formation on the weekly time frame is suggesting a temporary exhaustion on the sellers side. However, it also shows lack of confidence among the buyers. Going into this week, the outlook on Nifty shall remain bearish with a 'sell on rise' approach until price trades below 24150. On the down side, 23450 and 23250 are considered as the support levels.

#### Index in 'distribution phase'.

A similar price action as Nifty was seen in Bank Nifty on Friday where the index gave up majority of its initial gains. Currently, Bank Nifty can be seen trading sideways within the broader range from 50000 to 54000. For Monday's trading session, 52000 is considered as a strong resistance and a positive bias can only be adopted once price closes above the same. 51000 is seen as an intraday support. A breakdown below the same can lead to an extended selling of 700-1000 points during upcoming sessions.
