



Commentary

- Nifty steadied around 24600 on Monday, ending nearly flat with a modest 19-point drop. Bank Nifty attempted a
 rebound from 54200, closing just below 54500. A 'doji' candle on the daily chart of Bank Nifty signals the
 possibility of an extended bounce.
- On the sectoral front, Oil & Gas stocks rallied on falling crude prices, while PSU Banks attracted strong buying. The FMCG index showed signs of selling exhaustion, hinting at a potential rebound. Lower crude prices are likely to continue benefiting OMCs, aviation, paints, autos, and FMCG.
- Ahead of the monthly expiry, a bounce in both Nifty and Bank Nifty looks likely. A breakout above 24800 in Nifty could trigger fresh long positions, opening room for a 150-200 point rally. For Bank Nifty, a move above 54700 may pave the way toward 55000.

- GIFT Nifty trading at ~24,682, signals a muted start.


