






<u>Index stands at decisive levels prior to 'Budget 2025' announcement.</u>

Nifty experienced high volatility on the monthly expiry and eventually closed on a positive note gaining 86 points. On its daily chart, the index can be seen arriving near the resistance zone around 23400 and hence, a cautious approach would be recommended around the same. As we head towards the 'annual budget' announcement on Saturday, more volatility can be seen creeping in. For Friday's trading session a 'buy on dip' approach is recommended with 23100 acting as a sturdy support.

Index trading around 'make or break' levels.

Bank Nifty saw another positive closing on Thursday gaining almost 150 points. However, on the daily chart, it has seen a 'spinning top' candle formation around the 20 DEMA which has been acting as a hurdle for the price off late. Hence, going into Friday's trading session, we maintain a cautious view around 49500 levels which can act as an intraday resistance for Bank Nifty. On the downside, 48800 and 48300 are seen as the support levels.
