



Buying interest across sectors leads to a bounce back in Nifty50 index.

Nifty bounced back from 24500 support and closed with a gain of 77 points on Wednesday. On its daily chart, the index can be seen consolidating within a broader range with lack of clarity among the buyers and sellers. As we head into the weekly expiry today, 24500 shall continue to act as a decisive support. In case of a breakdown below the same, an extended correction of 200-350 points can be seen with 24150 as the next support. An immediate resistance stands at 24700.

INDEX VIEW: BANK NIFTY

Bank Nifty traded sideways during Wednesday's trading session and closed with a gain of 76 points after price recovered from lower levels of 55400. On its daily chart, the index has witnessed a 'Doji' formation which indicates lack of clarity among the market participants as of now. For Thursday's trading session, 55000-56000 is seen as the broader range for Bank Nifty while a further clarity can only be obtained once price breaks out of the given range.
