



Consolidation persists amid global uncertainties.

Market continued with the choppy movement on Monday as Nifty traded within a narrow range of 100 points and closed with a gain of more than 100. However, the index was yet again seen facing rejection from 24500 level making it a crucial resistance for Tuesday's trading session as well. On the other hand, 24200 shall be acting as an immediate support level followed by 24000.

Index slips below 55000.

Bank Nifty declined by nearly 200 points on Monday and closed below 55000. Going into today's trading session, 54700 shall continue to act as the support level while a breakdown below the same might lead to an extended correction of 500-700 points. At the higher end, 55300 is seen as the resistance level.


