





Index recovers post a gap down opening, auto stocks gain.

Post a gap down opening on Wednesday, Nifty witnessed a quick reversal from the support of 24200 and recovered all the losses to close with a gain of 34 points. On it's daily chart, price can seen in a consolidation mode. Going into today's weekly expiry, the sideways move is expected to continue with 24200-24500 acting as an initial range. A positive stance can only be taken once the index starts sustaining above 24500 levels. On the other hand, a break down below 24200 might lead to an extended correction of 150-200 points.

INDEX VIEW: BANK NIFTY





Index holds on to 54000 on closing basis.

Bank Nifty saw a significant recovery from the lower levels post a gap down opening and closed with a gain of 339 points. On its daily chart, the index can be seen trading within a corrective channel with 20 DEMA acting as the support. Heading into Thursday's trading session, a positive bias can be maintained on Bank Nifty till price sustains above 53850. A bounce back of 400-900 points can be seen in the index with 55000 and 55250 acting as the resistance levels. An immediate support is expected at 54000.
